1. **Conditional Use Permit/Abutters:** Jason Parker (Green Tip Cannabis, Inc.)
 - J. Larson reviewed the details of Green Tip Cannabis, Inc. via CUP application and previous CPB meetings;
 - J. Parker is not working within a collective and a future collective is not allowable on site;
 - Signage will separate retail (selling glass pipes, t-shirts, candles, etc.) from consultant's office (no cultivation or storage on site); no site walk needed;
 - J. Parker provided brief bio to include his reason for choosing Cornish as a venue when not a resident (affordability, accessibility);
 - Green Tip Cannabis, Inc. operates under medicinal ordinances; additional application needed for recreational
 - Business must abide by age limit for adult patients and patrons;
 - Formal application will be addressed and voted on per March 6th CPB Business Meeting
