

Town of Cornish, Maine SELECTMEN MEETING MINUTES Wednesday, May 15, 2024 @5:00



- Selectboard Member, Chair Jessica Larson called the meeting to order @ 5:04 P.M.
- Roll Call Chair Jessica Larson, Dan Sherman David Pike, Monique Guptill, M. Angel Eastman pre-diem Secretary, Dee Hartford were present.
- All Payroll and Accounts payable warrants were reviewed and approved by all Selectboard Members.

- Bango Savings Yearly Meeting Monique Guptill (Town Clerk) has contacted Kattie, will meet September or October.
- Jessica Larson has been in contact with Jen Lewis (Selectboard of Parsonsfield).
 - Cornish Emergency Disaster Plan.
 - Jen Lewis would like to call SAD#55 towns together to work on this.
- Cornish Fire truck leaves for Ohio 05/20/24. Chief Chris Calhan will be driving the fire truck out.

New Business:

- o Park and flag List of things to be done.
 - Eagle Park
 - Lattice around the bottom of the gazebo. Brent Nelson
 - Sealer on the gazebo, Keos, rails, and on the fence. Brent Nelson
 - Branch by the bridge to be remove. Selectboard mention that can be removed the same time that Alex Moody removes the big tree.
 - The motorcycle pad and the parking lot needs sweeping. Monique Guptill will contact Sturgeon.
 - There needs to be a contract drawn up with certificate of insurance and agreement of
 fixing the lawn. The company name is Pratt & Sons from Mechanic Falls. This would be
 for using the Park for there equipment while working on Route 25. The Park will have to
 be closed off if this action happens.
 - Thompson Park
 - Brent Nelson will wash down the fencing and will paint at a later date.
 - Brent Nelson has repaired the Keos.
 - Town Hall
 - Kios has been repaired. Brent Nelson will find someone to do the painting and lettering.
- Dee Hartford will contact the Fire Marshell for Pike Hall if needed, which must be inspected every year.
- Jennifer Pride
 - Would like a speed limit sign placed on School Street.
 - Requires MDOT approval with a speed study.
 - Dee Hartford will contact MDOT for a speed study on School Street.

Public Comments:

- Diann Perkins Chair of The Cornish Fairgrounds Advisory Board.
 - Diann explained the history of the grandstands.
 - 1997 Sebgo Tec brought the grandstands up to code.
 - Diann Perkins will call Fryeburg to see how they deal with Fire Marshel inspections.
 - The Fire Marshel (Scott Cyr) will not inspect the fairgrounds until there is a letter from a Maine licensed architect/engineer that has had an evaluation within the last 12 months and provided a report that has been evaluated to the current adopted code NFPA 102.
 - Dan Vaillancourt (CEO) recommended Criterium Engineers (1-800-242-1969).
 - Results still doing research.
- Brent Nelson will do the Town Hall parking lot stripping.
- Communication Tower
 - East Coast Bell Atlantic.
 - Certificate of Insurance.
 - Earth work, construction, and road.

- Steve Gowing (bid on the Old Fellows Hall) Does not have a crew this summer. He is not sure if he could get the Old Fellows Hall done at all.
- Selectboard is looking into the second bidder (Painting by Pond Scott Kruse).

 - Jessica Larson (Chair) will write a letter to Collins and Libby with some concerns.
- Dan Sherman mentions Monique Guptill about making sure the accounts for M. Angel Eastman (P/T per diem) and Dee Hartford (Town Deputy clerk) were being kept up to date.
- Dee Hartford will contact Mike Sturgeon(water district) on filling some of the water shut off holes.
