

Town of Cornish, Maine SELECTMEN MEETING MINUTES Wednesday, November 13, 2024



- Selectboard Member Chair Jessica Larson called the meeting to order @ 5:01 P.M.
- Roll Call Chair Jessica Larson, Dan Sherman, David Pike, Monique Guptill, Dee Hartford, M. Angel Eastman per-diem Secretary.
- All Payroll and Accounts payable warrants were reviewed and approved by all Selectboard Members.
- Minutes from October 30, 2024, were approved by all Selectboard Members.

TOPICS DISCUSSED:

 - Sacopee Rescue Unit
 - Beverly Russell Treasurer
 - The Selectboard and Beverly have agreed on changing the installment payments in the Article for the Annual Town meeting 2025.
 - As read now:
 - To see if the town will vote to raise an appropriate sum \$101,808.00 for maintenance and operations cost for Sacopee rescue, to be paid in three equal installments: the first payable on or before April 15,2024, the second payable on or before August 15, 2024, and the third payable on or before November 15, 2024. All contingent upon a fully executed contract.
 - Proposed article:
 - To see if the town will vote to raise an appropriate sum of \$\$\$\$\$ for maintenance and operation cost for Sacopee rescue, to be paid in four equal installments: the first payable on or before April 15, 2025, the second payable on or before June 15, 2025, and the third payable on or before September 15, 2025, and the fourth payable on or before November 15, 2025.
 - The final proposed article is due December 1, 2024.

 - The town assessors denied Benggio tax abatement.
